Certificates of Baptism</b><br>The fee for a certificate issued at the time of baptism is for a certified copy of the entry in the register book of baptisms giving the particulars required in Form No 1 in Schedule 1 to the Parochial Registers and Records Measure 1978. The fees payable for a certified copy of the full entry issued at any other time are the fees prescribed for searching registers of baptisms and burials and, if applicable, for each additional copy of an entry in such a register.<br><br><b>A2. Searches in Church Registers</b><br>The search fee relates to a particular search where the approximate date of the baptism or marriage is known. The fee for a more general search of a church register is negotiable.<br><br><b>A3. Costs and Expenses</b><br>In the case of a marriage service in church, any costs and expenses incurred in respect of routine administration (including arranging dates and times and the making of entries in registers), making the church available and lighting it are included in the fee prescribed as payable to the parochial church council.<br><br><b>A4. Fee for Marriage Certificate</b><br>The following fees are currently payable under the Marriage Act 1949 to the parochial church council under the Registration of Births, Deaths and Marriages (Fees) (Amendment) Order 2014: certified copy of entry in marriage register at time of registration £4.00; subsequently £10.00. The fees in note A4 may be increased from 1 April 2017 |

Definitions etc.</b><br><i>'Burial'</i> includes deposit in a vault or brick grave and the interment or deposit of cremated remains.<br><i>'Churchyard'</i> includes the curtilage of a church and a burial ground of a church whether or not immediately adjoining such church. (NOTE: This includes any area used for the interment of cremated remains within such a curtilage or burial ground, whether consecrated or not.)<br><i>'Cemetery'</i> means a burial ground maintained by a burial authority.<br><i>'Monument'</i> includes headstone, cross, kerb, border, vase, chain, railing, tablet, plaque, marker, flatstone, tombstone or monument or tomb of any other kind.<br><i>'Immediately preceding or following on from service in church'</i> includes the day before and the day after the service in church. Where " - " appears in the table no fee is payable to the body indicated. |

Funerals &amp; Burials</b><br>i) No fee is payable in respect of a burial of a still-born infant, or for the funeral or burial of a person dying within sixteen years after birth.<br>ii) The fee for a burial in a churchyard or cemetery on a separate occasion applies when burial does not take place on the same day as, or on the day before or the day after, a service in church.<br>iii) The certificate issued at the time of burial is a certified copy of the entry in the register book of burials kept under the Parochial Registers and Records Measure 1978.   |
